6. The undersigned understand and agree that upon the acceptance of this Contract by the School, I (we) shall become fully and unconditionally obligated to fulfill all of the terms and conditions hereof, that I (we) will be responsible for making all payments required hereunder for the full School Year, and that no portion of such charges so paid or outstanding will be refunded or canceled notwithstanding the subsequent absence, withdrawal, or dismissal from School of the above named student(s).

7. The undersigned understand and agree that: (1) No report cards will be issued if any account is past due; (2) No student will be readmitted second semester for whom accounts are past due; (3) No credits will be given to the above named student(s) until all financial obligations have been fully discharged.

8. As additional consideration for the acceptance of this Contract, and as material inducement to the School to accept same, the undersigned irrevocably covenant and agree as follows: (a) That we, as parents or guardians of the above named student(s), understand that the School is a private institution, and agree that any or all of the above named student (s) may be required to withdraw from the School at any time such withdrawal is in the best interest of either the School or the said student(s), is in the sole absolution of the School; (b) That we on behalf of ourselves and the above named student(s), consent and agree to all rules, regulations and policies of the School, now in effect or which may be made known at any time in the future by the School during the term of this Contract, and willfully abide by same; (c) That we hereby consent and agree that the School may at any time suspend, dismiss, expel or require the withdrawal of any student, or withhold credit for any School work done, where proper under the existing School regulations or policies, and that the decisions of the School in such respect shall be final and fully binding upon us and our said student(s); (d) That we hereby covenant and agree to hold the School harmless for any loss, harm, or damage claimed to arise out of the School's rights under this contract; (e) It is further agreed that in the event parent or guardian defaults in the payment as stipulated herein, the parent or guardian shall be liable for all costs of collecting including reasonable attorney's fee incurred by the School; and, (f) I understand and agree that my child may be randomly selected to submit to drug testing for detection of prohibited substances and testing for alcohol.

9. The school shall not be responsible for damages to or losses of personal belongings.

10. In accordance with "Section 8" of the School's Bylaws, "the Board of Directors shall have the power to levy assessments upon each and every member of the corporation when is deemed to be in the best interest of the corporation."
